New public notice rates take effect July 1

Effective July 1, the public notice advertising rate will increase from 52.4 cents for a 12- pica wide line of eight-point type (or its equivalent) to 56.7 cents per line (38.2 cents per line for subsequent insertions). These rates should be charged for all public notices published on or after July 1, 2022. 2022 marks the twentieth year in which public notice rates have increased (they decreased in 2009 and 2015). Public notice rates are tied to the consumer price index as a result of a bill backed by the INA and passed by the Legislature in 2000.

Accepting nominations for Master Editor-Publisher award

The floor is now open for 2023 Master Editor-Publisher nominations. The MEP award may be given to any person who at the time of selection is actively engaged in editing and/or publishing a newspaper which is a member in good standing of the INA. The four selection criteria are:

- the nominee has worked hard;
- the nominee has thought soundly;
- the nominee has influenced unselfishly; and

- the nominee has lived honorably.

Nominations will be reviewed by a selection committee made up of past MEP award winners. Winners will be announced at the 2023 INA Awards Banquet. Deadline for submitting a written nomination is August 1, 2022.

Accepting nominations for Distinguished Service award

Do you have a colleague who deserves recognition for exemplary service to his/her community and to Iowa's newspaper industry?

The INA encourages you to nominate that person for its 2023 Distinguished Service Award (DSA). This award was created to recognize contributions in three key areas: newspaper, community and the industry as a whole.

Candidates are not limited to publishers and editors. They might be advertising directors, circulation managers, backshop supervisors, business managers, news and sports editors or other staff members.

A nomination form is included in this week's Bulletin. All nominations must be submitted in writing by Aug. 1, 2022, to be considered for selection. The reverse side of the nomination form has a list of past DSA winners. These past recipients comprise the selection committee, which meets to determine which nominees best meet the following DSA criteria:

- The nominee must be an employee of, former employee of, or contributor to an Iowa newspaper or associated with a university, college or newspaper association having close

ties with Iowa newspapers;

- The nominee shall have contributed greatly to his or her newspaper, and to his or her community and/or the newspaper industry in general;
- Longevity should have little effect on the nominee's qualifications.
- Individuals who have received the INA's Master Editor-Publisher award are not eligible to win the Distinguished Service Award.

The award qualifications were modified last year with the addition of the words "or contributor," to allow for an individual that has significantly contributed to the industry, but is not employed by it, to be honored. The new wording has been incorporated into the qualifications listed above and on the enclosed nomination form.

This award is one of the most prestigious awards given to newspaper professionals in Iowa. It will be presented during the 2023 INA Awards Banquet.

Please share with your staff this opportunity to nominate a worthy candidate.

INF Receives Grant Funding for Newspaper Intern Workshop

Iowa Freedom of Information Council offers free courtroom training

The Iowa Freedom of Information Council and Iowa Judicial Branch will conduct a training program on Friday, July 1 for journalists in Council Bluffs, Iowa who want to use cameras, laptop computers, audio recorders or smartphones inside Iowa courtrooms.

There is no charge for this program. No reservations are necessary. The training will be repeated in the coming weeks in west central, northwest, southeast and far eastern Iowa.

The July 1 event will be in Council Bluffs from 10 a.m. until 11:30 a.m. at the Council Bluffs Public Library. You can find details on the attached flyer.

It is important that journalists -- photographers, videographers, reporters, assignment editors, etc. -- in southwestern Iowa make time for this training if you or



your staff want to use electronic gear inside Iowa courtrooms. This training is being held to avoid problems in courtrooms like those that occurred during the recent trial of the man accused of killing Mollie Tibbetts.

Because electronic gear is permitted in courtrooms only with the permission of the presiding judge, it is important that everyone have a thorough understanding of the do's, don'ts and procedures for Iowa's Expanded News Media Coverage rules established by the Iowa Supreme Court.

Avoiding problems is important, because judges have the authority to punish those who violate the court rules. That punishment could range from a verbal reprimand, to banning the journalist or his/her employer from using digital gear in future court proceedings, to criminal contempt-of-court charges against the journalist.
